1. The Services

- A. C Bar L Ranch will provide client with 4 group riding lessons scheduled once a week on Wednesdays and 1 clinic/social per month.
- B. Client will provide the lesson horse, saddle, bridle and all equipment for the horse
- C. C Bar L Ranch will provide riding instruction
- D. Riders will be automatically be grouped together with riders of similar ability and level. This is paramount to our barn culture and philosophy of creating a community that encourages camaraderie, friendship and support. We feel this leads to higher quality riding, lessons, and just plain more fun.

4. Scheduling

- A. Client will receive a dedicated time on Wednesday of each week with a group of 2 to 5 riders with similar ability reserved each week.
- B. If client cannot make their time during a week- C Bar L Ranch will allow a maximum of one makeup lesson per month. An attempt will be made to try and find an additional time for the student where there is an appropriate group, however because of the complexities of scheduling- there are no guarantees. Monthly tuition is still due in full when student misses their lessons. In the event that the weather prevents a scheduled lesson, C Bar L Ranch will make every effort to reschedule the lesson day. The best way to get the most value out of the program is to make it a priority and a commitment not to miss your dedicated lesson time(s)
- C. If client would like to make a long-term change to their dedicated lesson time, they may do so a maximum of 1 time in a 90 day period by calling or texting 940-872-0497 and leaving a voicemail.
